6. Selection process	a. The Winner of the Major Prize will be determined as follows: i. Entrants who have submitted five (5) entries containing a correct guess of the home appliance featured in the sound effect played on air each day during the Promotional Period will be entered into the Major Prize draw. ii. If there are no Entrants who have submitted five (5) entries containing a correct guess, the Major Prize draw will be conducted from all Entrants who have submitted the most entries containing correct guesses (i.e. four (4) correct entries or if no Entrants submit 4 correct entries, (3) correct entries and so on). If no correct entries are received, all valid entries received will be entered into the Major Prize Draw. iii. The first valid and correct entry drawn will receive the Major Prize. b. The Promoter may draw additional reserve entries and record them in order in case an invalid entry or ineligible entrant is drawn. c.
